Bids will be opened online on the specified date and time. In event of the date specified for opening of bids being declared as a closed holiday for purchaser's office, the due date for submission of opening of bids will be the following working day at the appointed time.
- 4. The Eligibility, Purchase Preference and other conditions as detailed in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012, issued by Ministry of Micro, Small and Medium Enterprises, Office of Development Commissioner (MSME) dated:23rd March 2012 amended time to time and Order No. P45021/2/2017-PP (BE-II) dated: 16 Sep 2020 issued by DIPP, Ministry of Commerce and Industries, GoI will also be applicable in addition to other conditions mentioned in this Tender Document. Bidders are mandatory to indicate whether they are MSEs/Startup along with their class based on Local Value addition i.e. Class I or Class II bidders.
- 5. The bidders offering imported products will fall under the category of Non-local suppliers. They can't claim themselves as Class-I local supplier/ Class-II local supplier by claiming profit, warehousing, marketing, logistics, freight etc. as local value addition.
- 6. Tender acceptance Letter as per Annexure 1 and Tender Check List are mandatory. Your bid shall be summarily rejected, if the same is not submitted along with tender. In case of any contradiction between the tender condition(s) and bid offered by you, tender condition(s) shall prevail as per the Tender Acceptance Letter.
- 7. CSIR-CSMCRI will not be the importer in any case, hence no documents (including CDEC) shall be issued by CSIR-CSMCRI for custom clearance.
