All bids must be accompanied with a bid security as specified above in the table and must be submitted online only on the CPPP Portal (<https://etenders.gov.in/eprocure/app>) on or before the date and time indicated above in para 3. Bids will be opened online on the specified date and time. In event of the date specified for opening of bids being declared as a closed holiday for purchaser's office, the due date for submission of opening of bids will be the following working day at the appointed time.

The Eligibility, Purchase Preference and other conditions as detailed in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012, issued by Ministry of Micro, Small and Medium Enterprises, Office of Development Commissioner (MSME) dated:23rd March 2012 amended time to time and Order No. P45021/2/2017-PP (BE-II) dated: 16 Sep 2020 issued by DIPP, Ministry of Commerce and Industries, GoI will also be applicable in addition to other conditions mentioned in this Tender Document. Bidders are mandatory to indicate whether they are MSEs/Startup along with their class based on Local Value addition i.e. Class – I / Class – II or Non-local bidders.
5. Tender acceptance Letter as per Annexure 1 and Tender Check List are mandatory. Your bid shall be summarily rejected, if the same is not submitted along with tender. 7. **If a Bidder Quote in INR then CSIR-CSMCRI will not be the importer and no documents (including CDEC) shall be issued by CSIR-CSMCRI for custom clearance.**
