Alternatively, the Tender documents may also be downloaded from our website https//:www.csmcri.res.in free of cost. However, all the bids are to be submitted online only on the CPPP Portal (https//:etenders.gov.in/eprocure/app)
- 2. The bids must be submitted online on or before 22.01.2024 (Date) up to 18:00 hours (IST) and shall be opened on **24.01.2024** (Date) at 11:00 hours. (IST)

- 3. All bids must be accompanied with a bid security as specified above in the table and must be submitted online only on the CPPP Portal (https://etenders.gov.in/eprocure/app) on or before the date and time indicated above in para 3. Bids will be opened online on the specified date and time. In event of the date specified for opening of bids being declared as a closed holiday for purchaser's office, the due date for submission of opening of bids will be the following working day at the appointed time.
- 4. The Eligibility, Purchase Preference and other conditions as detailed in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012, issued by Ministry of Micro, Small and Medium Enterprises, Office of Development Commissioner (MSME) dated:23rd March 2012 amended time to time and Order No. P45021/2/2017-PP (BE-II) dated: 16 Sep 2020 issued by DIPP, Ministry of Commerce and Industries, GoI will also be applicable in addition to other conditions mentioned in this Tender Document. It is mandatory for the bidders to indicate whether they are Class I / Class II or Non-local bidders on the Local Value addition.
- 5. Tender acceptance Letter as per Annexure 1 and Tender Check List are mandatory. Your bid shall be summarily rejected, if the same is not submitted along with tender. In case of any contradiction between the tender condition(s) and bid offered by you, tender condition(s) shall prevail as per the Tender Acceptance Letter.
- 6. The bidders offering imported products will fall under the category of Non-local suppliers. They can't claim themselves as Class-I local supplier/ Class-II local supplier by claiming profit, warehousing, marketing, logistics, freight, transportation, insurance, installation, commissioning, training and after sales service support like AMC/CMC etc. as local value addition.
- 7. If a Bidder Quote in INR then CSIR-CSMCRI will not be the importer and no documents (including CDEC) shall be issued by CSIR-CSMCRI for custom clearance.
- 8. The Director, CSIR- CSMCRI, Bhavnagar reserves the right to accept or reject any bids or accept all tenders either in part or in full or to split the order, or to annul the bidding process without assigning any reason.
