- 1. The tentative date of Typing Test is 24th May to 25th May, 2025.**
- 2. The tentative date of Written Competitive Examination is 8th June, 2025.**
3. The Schedule of Typing Test shall be notified in due course of time on Institute's website. Therefore, the candidates are advised to keep a regular watch on the website of the Institute.
4. The final list of candidates notified for Typing Test is based on the information submitted by the candidates at the time of online application.
5. The primary scrutiny of essential educational-qualification and the other essential certificates of the candidate have been done at this stage. Therefore, all the documents of educational qualification, proof of age etc. of those candidates who qualify in the Typing Test will be thoroughly verified before allowing them to appear in the Written Examination. Those who do not fulfil terms and conditions and eligibility as per the advertisement for the post under reference shall be summarily rejected, even if, a candidate is qualified in the typing test.
6. Those candidates, who have been declared eligible subject to production of certain documents, shall be required to produce such documents before the Typing Test.
7. The candidates shall be required to submit testimonials/certificates/documents, including a caste certificate for verification as and when desired by this Institute as per para V.10 of the the Advt. No. 1/2025.
8. Any wrong or incomplete information furnished by the candidate shall render her/him ineligible for consideration without any further notice as per para V.10 of the the Advt. No. 1/2025.
9. If on verification either before or after at any of the stage of selection process, it is found that the candidate does not fulfil any of the eligibility conditions, his/her candidature will be summarily cancelled forthwith as per para V.21 of the the Advt. No. 1/2025

10. The candidature is provisional at all the stage of recruitment process and hence will be considered only if meeting the minimum eligibility criteria as per this advertisement and Recruitment Rules of CSIR.
11. Merely being shortlisted for Typing Test does not vest a right upon any candidate to be eligible for a Written Competitive Examination or for appointment to the post.
