NOTIFICATION

**Subject: Recruitment of Group-IV Scientists at Entry Level for CSIR-CSMCRI notified
vide Advt No. 2/2024**

With reference to the Advt No. 2/2024 of CSIR-CSMCRI, Bhavnagar, a Screening Committee was constituted for each Post Code under Rule 6.5.2 of CSIR Scientists Recruitment & Assessment Promotion rules (CSRAP), 2001, to screen the applications of candidates who had applied online for the posts of Scientist against the CSIR-CSMCRI Advertisement No.2/2024.

2. The duly constituted Screening Committee perused each application, along with the uploaded supporting documents like certificates of date of birth, educational qualifications and the research/work experience, etc.
3. Keeping in view the number of applications received against each post code [i.e. Post Codes 1, 2, 3, 4, 5 & 6], the Screening Committee adopted the screening criteria for each post code to short-list the candidates for interview. The Screening Criteria adopted by the Screening Committee for each post code, List of Provisionally Short-listed candidates for interviews and Not-Shortlisted/Screened-out candidates are annexed at **Annexure- A to F**
4. The Screening process has been done based on the details/information furnished by the candidates in their online application forms and the documents uploaded by them. The primary scrutiny of essential educational qualifications and the other essential certificates of the candidate has been done at this stage. Therefore, all documents related to educational qualifications, proof of age, etc., of the shortlisted candidates will be thoroughly verified before they are allowed to appear for the Interview. Those who do not fulfil the terms and conditions and eligibility as per the advertisement for the post under reference shall be summarily rejected, even if a candidate has been shortlisted for an Interview.
5. **The candidature of all screened-in/shortlisted candidates is purely provisional** and mere appearance of the name in the list of shortlisted candidates as per **Annexure-A to F** does not entitle any candidate to be called for the interview. If at any stage of the recruitment process, it is found that the information furnished by applicant(s) in their online Application Form is incorrect/ false or suppressed any material information or does not meet the essential qualification and screening criteria adopted by the Screening Committee, his/her candidature will be cancelled without any further notice, even after selection to the post.
6. Merely being shortlisted for Interview does not vest a right upon any candidate to be eligible for appointment to the post.
7. Age relaxation sought by the candidates have been checked with the supporting documents they have provided. Those who have not provided their supporting documents for age relaxation have not been considered for age relaxation and hence declared as ineligible being over age. The candidates who have been shortlisted, subject to the production of the requisite documents as mentioned against their names in Annexure A to F, have to compulsorily forward the requisite document(s) from their registered email id to recruitment@csmcri.res.in by 20.10.2025 failing which their candidature will be cancelled.

8. Relaxation/concessions given to candidates is subject to verification of relevant certificate/documents.
9. Document(s) so received from candidate(s) will be scrutinized by the Competent Authority for final decision regarding their eligibility.
10. While every care has been taken in preparing the list in Annexure-A to F, the CSIR- CSMCRI, Bhavnagar reserves the right to rectify inadvertent error or typographical/printing mistake, if any, at any stage.
11. The candidates shall be required to submit testimonials/certificates/documents, including a caste certificate, for verification as and when desired by this Institute.
12. Representations from the candidates against the provisional list are invited through email only on the email I.D. recruitment@csmcri.res.in Representations may be sent with the subject line "Representation for Post code No. ----- against Advertisement No. 2/2024" duly attaching therewith the relevant documents in support of his/her claim on or before 11.59 PM on 20th October 2025. The representation(s) received after 20th October, 2025 will not be entertained.
13. The decision of the Competent Authority, CSIR-CSMCRI on such representations will be final and binding.
14. After approval of the Competent Authority, final list of candidates shortlisted for interview for each post code will be published on CSIR-CSMCRI website www.csmcni.res.in
15. Any further information regarding this Advertisement, like date and time of Interview or otherwise, any addendum/corrigendum or any variation(s) will be notified through the CSIR-CSMCRI website www.csmcni.res.in only. Therefore, the candidates are advised to keep a regular watch on the website of the Institute, accordingly.
