1. The candidature of all screened-in/shortlisted candidates is purely provisional and mere appearance of the Registration ID in the list of shortlisted candidates as per Annexure-A does not entitle any candidate to be called for the Written Examination. If at any stage of the recruitment process, it is found that the information furnished by applicant(s) in their online Application Form is incorrect/false or they have suppressed any material information or does not meet the essential qualification as per the advertisement, their candidature will be cancelled without any further notice, even after selection to the post.
2. The candidates shall be required to submit testimonials/certificates/documents including caste certificate for verification as and when desired by this Institute.
3. Merely being shortlisted for Written Exam does not vest a right upon any candidate to be eligible for appointment to the post.
4. Those candidates, who have been declared eligible subject to production of certain documents, shall be required to produce such documents before the Written Exam through email to recruitment.csmcri@csir.res.in failing which their candidature shall be cancelled.
5. The documents submitted by the candidates, who were declared eligible subject to production of certain document as per notification of even number dated 21.01.2026, have been examined as per rules and their final eligibility or ineligibility have been decided accordingly.
6. Those of the candidates, who were declared eligible subject to production of certain documents as per notification of even number dated 21.01.2026 but have not submitted any documents, have been declared ineligible as per para 7 of the notification dated 21.01.2026.
7. Representation received have been examined and eligibility or ineligibility of the concerned candidates have been decided and notified accordingly.
8. Relaxation/concessions given to candidates are subject to verification of the relevant certificate/documents.
9. While every care has been taken in preparing the list in Annexure-A, the CSIR- CSMCRI, Bhavnagar reserves the right to rectify inadvertent error or typographical/printing mistake, if any, at any stage.
10. **The tentative date of Writtten Examination is 15th March, 2026 and Exam will be conducted in Bhavnagar.**
